1. A bidder desirous of taking part in a tender shall login to the e-Procurement Portal of the Government of West Bengal <http://wbtenders.gov.in> using his login ID and Password and thereafter may download the tender document from the website directly with the help of Digital Signature Certificate. **Necessary** Cost of tender documents (tender fees) and earnest Money may be remitted through Net Banking or RTGS/NEFT and also to be documented through e-filling.

As per G.O. No. 3975-F(Y) dated 28.07.2016 of the Secretary, Audit Branch, Finance Department a bidder should initiate payment of pre-defined EMD for the tender by selecting from either of the following payments modes:

- i) Net Banking (any of the banks listed in the ICICI Bank Payment Gateway) in case of payment through ICICI Bank Payment Gateway;
- ii) RTGS/NEFT in case of offline payment through bank account in any Bank.

2. Both Technical Bid and Financial Bid are to be submitted as per time schedule stated, concurrently duly digitally signed by the bidder in the website <http://wbtenders.gov.in>

1) Earnest Money Payment Procedure :

a) Payment by Net Banking (any listed bank) through ICICI Bank Payment Gateway:

i. On selection of net banking as the payment mode, the bidder will be directed to ICICI Bank Payment Gateway webpage (along with a string containing a Unique ID) where he will select the Bank through which he wants to do the transaction.

ii. Bidder will make the payment after entering his Unique ID and Password of the Bank to process the transaction.

iii. Bidder will receive a confirmation message regarding success/failure of the

v. If the transaction is failure, the bidder will again try for payment by going back to the first step.

b) **Payment through RTGS/NEFT :**

- i. On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filled challan having the details to process RTGS/NEFT transaction.
- ii. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT payment using his Bank account.
- iii. Once payment is made, the bidder will come back to the e-Procurement portal after expiry of a reasonable time to enable the NEFT/RTGS process to complete, in order to verify the payment made and continue the bidding process.
- iv. If verification is successful, the fund will get credit to the respective pooling account of the state Government/PSU/Autonomous Body/Local Body/PRI, etc. Maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road, Kolkata for collection of EMD/Tender Fees.
- v. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- vi. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

II) Earnest Money Refund/Settlement Process :

- i) After opening of the bids and technical Process of the same by the tender inviting authority through electronic Processing in the e-Procurement portal of the State Government, the tender inviting authority will declare the status of the bids as successful or unsuccessful which will be made available, along with the details of the unsuccessful bidders, to ICICI Bank by the e-Procurement portal through web services.
- ii) On receipt of the information from the e-Procurement portal, the Bank will refund, through automated process, the EMD of the bidders disqualified at the technical evaluation to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of bid is uploaded to the e-Procurement portal of the tender inviting authority.
- iii) Once the financial bid evaluation is electronically processed in the e-Procurement portal, EMD of the technically qualified bidders other than that of the L1 and L2 bidders will be refunded, through an automated process, to the respective bidders' bank accounts from which they made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on rejection of financial bid is uploaded to the e-Procurement portal by the tender inviting authority. However, the L2 bidder should not be rejected till the LOI process is successful.
- iv) If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurement portal, EMD of the L2 bidder will be refunded through an automated process, to his bank account from which he made the payment transaction. Such refund will take place within T+2 Bank Working Days where T will mean the date on which information on Award of Contract (AOC) to the L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.
- v) As soon as the L1 bidder is awarded the contract (AOC) and the same is processed electronically in the e-Procurement portal – a) EMD of the L1 bidder for tender of State Government offices will automatically get transferred from the pooling account to the State Government deposit head "8443-00 -103-001-07" through GRIPS along with the bank particulars of the L1 bidder.
b) EMD of the L1 bidder for tenders of the State PSUs/Autonomous Bodies/Local Bodies/PRI, etc will automatically get transferred from the pooling account to their respective inked bank accounts along with the bank particulars of the L1 bidder. - vi. The Bank will share the details of the GRN o. generated on successful entry in GRIPS with the EProcurement portal for updation.
- vii. Once the EMD of the LI bidder is transferred in the manner mentioned above, Tender fees, if any, deposited by the bidders will be transferred electronically from the pooling account to the Government revenue receipt head "0070-60-800-013-27" through GRIPS for Government tenders and to the respective linked bank accounts for State PSU/Autonomous Body/Local Body/PRIs, etc tenders.
- viii. All refunds will be made mandatorily to the bank A/c from which the payment of EMD& Tender Fees (if any) were initiated.

III) Accounting and Monitoring Process:

- i. The ICICI Internet Banking will communicate to the State Government e-Procurement portal all details
- ii. The Tender Inviting Authority of the Government Offices/PSUs/ Autonomous Bodies/Local Bodies/PRIs, etc will be using their respective e-procurement User ID and Password to view the EMD and Tender Fe 5 deposited by the bidders in the pooling accounts.
- iii. The nodal officer of the Finance Department, Government of West Bengal will be able to view the Department-wise EMD and Tender Fees deposited by the bidders to the pooling accounts and fund transferred downstream at various stages of the tender process to the Government accounts an bidders' accounts, as applicable by using user access as provided by NIC.
- iv. The details of NIC E-Procurement Help Desk and toll free numbers of ICICI Bank are given in annexure of the mentioned G.O. above.

2) Both **Technical Bid** and **Financial Bid** are to be submitted online on or before last date of Bid Submission date concurrently duly digitally signed in the website <http://wbtenders.gov.in>

3) Tender documents may be downloaded from website and submission of **Technical Bid** and **Financial Bid** will be done as per Time Schedule stated in Sl. No.-6.

4) The **FINANCIAL OFFER** of the prospective tenderer will be considered only if the **TECHNICAL BID** of the tenderer is found qualified by the 'Tender Evaluation Committee' formed by the authority. The decision of the 'Tender Evaluation Committee' will be final and absolute in this respect. The list of Qualified Bidders will be displayed in the website.

5) Eligibility Criteria for participation in the tender –

a) **Bonafied, reliable, resourceful and experience contractor or outsider or reputed firm having an experience of supplying at least same types of vehicles in a single tender under Government , Public Sector, Government autonomous body within last 3(Three) Financial Years. Credential means completion certificate as well as payment certificate of a single contract. [Non-statutory documents]**

b) **The Bidder/Manufacturer must have at least 3(Three) years experience in manufacturing or as dealer of same type of vehicles and Certificate of Satisfactory performance of minimum one year is to be furnished.**

c) **Uploading of scan copies of Pan Card, GST Registration Certificate, Professional Tax (PT) payment certificate (current), Income Tax Return (Last Three Previous year) & Valid Trade License, Solvency Certificate 50% of Quoted Amount** are to be accompanied with the Technical Bid Documents. d) **The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.**

e) **The Bidder/ Manufacturer must have service centre with requisite available spares in within 100KM of Khardah Municipality Proper address and location must be mentioned in the bid.**

After verification if it is found that the documents submitted by the lowest tenderer is either manufactured or false in that case work order will not be issued in favour of the said Tenderer under any circumstances.

i. Registration of Contractor/Supplier:

Any tenderer willing to take part in the process of e-tendering will have to be enrolled and registered with the Government e procurement system, through logging on to <https://etender.wb.nic.in>. The tenderer is to click on the link for e-tendering site as given on the web portal.

ii. Digital Signature certificate (DSC):

Each contractor is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders from the approved service provider of the National Informatics Centre (NIC) on payment of requisite amount. Details are available at the Web Site stated in Clause (i) above. DSC is given as a USB e-Token.

iii. The contractor can search & download N.I.T. & Tender Document(s) electronically from computer once he logs on to the website mentioned in Clause (i) using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

iv. Submission of Tenders: Tenders are to be submitted through online to the website stated in Clause (i) in two folders at a time for each work, one in Technical Proposal & the other is Financial Proposal before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

2) Technical Proposal:

The Technical proposal should contain scanned copies of the following in two covers (folders).

3) Tender Evaluation Committee (TEC)

Evaluation Committee constituted by the Competent Authority of Khardah Municipality will function as Evaluation Committee for selection of Technically Qualified Contractors.

4) Opening & evaluation of tender:

If any contractor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished.

5) Opening of Technical Proposal:

- i) Technical proposals will be opened by the Concerned Tender Inviting Authority or his authorized representative electronically from the website using their Digital Signature Certificate (DSC).
- ii) Intending Tenderers may remain present if they so desire.
- iii) Cover (folder) for Statutory Documents [Ref. Section A, 2(A)] will be opened first and if found in order, cover (folder) for Non-Statutory Documents [Ref. Section A, 2(B)] will be opened. If there is any deficiency in the Statutory Documents the tender will summarily be rejected.
- iv) Decrypted (transformed into readable formats) documents of the non-statutory cover will be downloaded & handed over to the Tender Evaluation Committee.
- v) Summary list of technically qualified tenderers will be uploaded online.
- vi) Pursuant to scrutiny & decision of the Tender Evaluation Committee the summary list of eligible tenderers & the serial number of work for which their proposal will be considered will be uploaded in the web portals.
- vii) During evaluation the committee may summon of the tenderers & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

ii) Only downloaded copies of the above documents are to be uploaded virus scanned & Digitally Signed by the contractor. Financial capacity of a bidder will be judged on the basis of information furnished by the Bidder.

7) Penalty for suppression / distortion of facts:

If any tenderer fails to produce the original hard copies of the documents like Completion Certificates and any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies, it may be treated as submission of false documents by the tenderer and action may be referred to the appropriate authority for prosecution as per relevant IT Act.

8) Rejection of Bid:

The tender accepting authority reserves the right to accept or reject any Bid and to cancel the Bidding processes and reject all Bids at any time prior to the award of Contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders of the ground for tender accepting authority's action.

ANNEXURE-I

Combined High Pressure Jetting cum Suction is robust built heavy duty Sewer Cleaning machine with latest state of art concepts and engineering technology. The machine is capable of de- choking the clogged sewer lines of size 100 mm to 1500 mm and capable of sucking silt from heavily silted sewer manhole / conduits constructed thereon up to depth of 7-12 meters.

The machine shall consist of a twin compartment tank of 6000 liters capacity along with suction pump and a jetting pump. The tank is divided in two compartments of 3000 liters for fresh water and 3000 liters for Sludge / sewage. The complete equipment shall be mounted on a Trailer Chassis. The machine will be supplied with following accessories having detailed specifications as below:-

1. Tank:

The tank shall be mounted with an arrangement for total internal volume of 6000 Liters. The tank shall be made of steel plates 5 mm thick conforming to IS 2062 Grade 'A' Standard. The tank shall be electrically welded with anti surge baffle plates welded internally. The inside of the tank shall be coated with epoxy paint. The compartment is divided in two compartments of 3000 liters for fresh water and 3000 liters for Sludge / sewage. Level indicators of transparent acrylic tubing with thick wall shall be provided on each of the compartment. The rear door shall be side hinged open able For internal maintenance of the water tank compartment a man entry opening with a lid shall be provided on top of fresh water compartment.

At the rear end door, the tank shall be provided with 100 mm suction cum drain valve at the bottom most position. The drain / suction valve shall be of Teflon with steel flange..

TECHNICAL DATA:

Total Capacity: 6000 Liters

Fresh Water Capacity: 3000 Liters

Sludge Compartment: 3000 Liters

Construction: Cylindrical shell with torrispherical dished end

1. Flushing Tank

3000 Liters capacity epoxy painted constructed out of 5 mm thick MS plate and rear inverted dished as per confirming to IS-2062 Grade A standard with drain valve and internal self-flushing strainer to filter the Water going into the pipe. A ladder will be provided on the tank to provide access to the top of tanks and a self-venting manhole will also be provided to allow entry into the tank. The manhole lid will be gasketed and the tank filter cap with sleeve will be fixed for airy operation and cleaning. A water level indicator will be provided on one side so on to give a clear view of water level.

2. Sludge Tank

Having a minimum capacity of 3000 Liters with arrangement of emptying by tipping through a discharge door and having a level side glass constructed out of 5 mm thick MS plate and rear inverted dished as per confirming to IS-2062 Grade A standard with epoxy painted inside and metal painted outside. Adequate safety device to protect the vacuum pump being damaged by the sludge going into the pump will be provided.

3. Suction (Vacuum) Pump : Make OMEGA (OMTC)

Suction (vacuum) Pump will be capable of creating a maximum vacuum 80-95% and emptying the chambers from depth of approximately 7 to 12 meters. The vacuum pump will be provided with:

- a) Injection Air Cooling System.
- b) Incorporated Automatic Lubricating oil pump.
- c) Incorporated 4-way valve.

The unit will be dry, rotary sliding vane type and vanes made from asbestos free, spark proof material and should be operating on the positive displacement principle without pulsation & without valves. The cylindrical bore of the Compressor casing housing an eccentrically mounted, cylindrical rotor with longitudinal bolt and the unit should be provided with an additional moisture trap for double protection of the system of the system from additional increase of water into the system.

Technical Data:

Delivery: min 430 cum/ hr free air flow;
Vacuum: min 90 %
Max. Pressure: 200 mbar
Lubrication: Automatic lubrication
Cooling: Air – Cooled

4. Blow back Arrangement

This arrangement will be made for the following operations:

- a) Stirring up the silt before commencing the suction operation
- b) Discharging the sludge, silt and water from the tank without door opening.

Sludge Stirring: The blow backpressure mode is utilized to stir up the sewer contents. This result in homogeneous mixing of the particle in the water content and all heavier particles/materials deposited at the bottom of the tank are brought up and kept in circulation before commencing the suction operation. The suction operation under this stage will effectively clean out complete sludge stagnated in the manhole suction/sewer line.

Sludge Blow Back Such an arrangement will be provided for discharging the water content of the sewer load through the pressurization mode without opening the door. Collected water content of the sludge tank will be discharged through the suction valve for enabling the vehicle to move from one application point to other carrying only sludge/material waste without transporting the unwanted water portion and there will be an arrangement also for discharging the entire sludge content through a separate drain outlet without resorting to door opening in the over pressure operation.

5. High-Pressure Jetting Pump Make of Jetting Pump :UDOR or ANNOVI REVERBER I ITALY

The High pressure jetting pump shall be a heavy duty positive displacement single acting triplex reciprocating pump to be driven by a split total power take off unit and will have a pressure and discharge rating of 150 bar with a Variation of minus zero percent and plus ten percent and 70 liters per minute. The system shall be adequately protected by incorporating suitable relief valves, unloaded valves, and Water filter and pneumatically actuated two way valve.

6. Drive System: The high pressure jetting cum suction pump and the hose reel hydraulic drive system to be driven by total Power Take off (P.T.O.) unit located between rear wheels of tractor. The PTO actuation to be effected pneumatically through control panel

7. Hose Reel and Hose

High Pressure hose reel of thermoplastic, lightweight and wear resistant material will be designed to hold 120 Mtr. of 27.6mm/ ¾" OD hose and the hose reel will be mounted on the rear of the tank by rigid supports. It shall be sufficiently strong to take hose under full load operational conditions. To ensure proper winding and unwinding of the hose on the hose reel, simple hose Guide will be provided as well. Guide pipe of suitable material for verifying depth of manhole will also be provided.

8. Sewer Hose

A sewer hose with 27.6 mm/ ¾" OD dia to withstand a working pressure of 250 bar with a variation of minus zero percent and plus ten percent and bursting pressure of 625 bar of light weight and war resistant thermoplastic material

9. Accessories
