On behalf of the board of councilors, The Chairman, Khardah Municipality, invites e-Tender (electronic tender process), for supply at site of 2000 numbers (1000 Numbers Green & 1000 numbers Blue) of HDPE plastic Green and Blue colour Household Bins of 10 litre capacity each. for conservancy department of Khardah Municipality from interested, reputed and bonafied Suppliers /Manufacturers/Dealers having experience and acumen in such work as noted below in the eligibility as depicted here under for participating in the Bid.

Details of tender with necessary requirement towards submission/ download of Tender Papers will be available from website: http://wbtenders.gov.indirectly with the help of Digital Signature Certificate (DSC).

- 2. Applicants willing to take part in the process of e-Tender will have to be enrolled & registered with the Government e-Procurement system; through logging on to https://wbtenders.gov.in using the option —Click here to Enroll. Possession of a Valid Class II Digital Signature Certificate (DSC) in the form of smart card/e-token in the Company's name is a prerequisite for registration and participating in the Quotation submission activities through this web site. Digital Signature Certificates can be obtained from the authorized certifying agencies, details of which are available in the web sitehttps://wbtenders.gov.in
- 3. Intending Quotationer/ Suppliers can search and download NI e-T and other Quotation documents electronically by logging on to the website https://wbtenders.gov.in, using his Digital Signature Certificate (DSC). This is the mode of collection of Quotation documents electronically.
- 4. For participating in the Quotation, the Quotationer shall have to pay the Earnest Money as specified in this NIeB shall be paid by online Internet Bank transfer or NEFT or RTGS (as per GO No. 3975-F (Y) dated 28.07.2016 of Finance Deptt., Govt. of West Bengal. Every such transfer shall be done on or after the date of publish of NIeB. Any bid without such transfer of Earnest Money (Except exemption as per G.O.) shall be treated as informal & shall be automatically cancelled. 5. Eligibility criteria for participation in Quotation:-

i) Bonafied, reliable, resourceful and experience manufacturer / dealer / supplier who have successfully completed not less than 40% value of tender amount in similar nature of work/ Supply in a single contract within last 5(Five) years from the date of issuing of the NIT under any Govt./ Semi Govt./ under taking organization. Credential means completion certificate as well as payment certificate of a single contract.

- ii) Manufacturers should have latest valid Trade License, Valid PAN no., Certificate of Provisional GST Registration/GST Registration Certificate with up to date challan, up to date Professional Tax Receipts, IT returns, Balance sheet of last three previous years.
- iii) The partnership firm shall furnish the registered partnership deed and the company shall furnish the Article of Association and Memorandum.
- iv) The prospective bidder should not have been Black Listed from any Government organization / Statutory Body etc. During the last 3 (Three) years. (A declaration in the form of Affidavit in a non-judicial stamp paper of Rs. 100/- duly affirmed before a Notary Public/1st Class Magistrate should be submitted without which the Technical Bid shall be treated as non responsive). Moulded from Food and Drug Administration (FDA) approved, special UV stabilized virgin grades of High Density Polyethylene (HDPE) material, manufactured from Injection Moulding Process. c. Absolutely smooth and sanitary, hygienic, chemical resistant, blended with stabilizers, Anti acidic, non toxic and fro joints, welds or rims. d. Must be provided with moulded handle of same (HDPE) material, for ease of lifting and lid of same HDPE material. e. Lids should be firmly fixable on the bins. Deformed or damaged bins, lids & handle will not be accepted. Lid & bins should be transported separately to avoid the damage and deformation of lid. f. Round in shape without sharp corners to prevent sticking of garbage. g. Must be strong & durable. h. Moulded built in bottom grip for easy lifting.



- i. Should be CIPET quality compliant.Detailed Specification:
 - a. Capacity 10 litres.
 - b. Minimum Weight: 550 Gms. (min.) with handle and lid.
 - c. Durability: Reusable, Washable, absolutely smooth and sanitary

It may be noted that the Authority will randomly selected bidder to undertake CIPET test and any other allied quality test at the cost of the selected bidder with the certification being provided in the name of Khardah Municipality. Any quality failure shall results in rejections of the supplied bins, if any without the Authority being liable for any financial losses arising out of the same. Rejection of quality may also lead to cancellation of order placed. KHARDAHA MUNICIPALITY reserves the right to modify the order quantity by (+/-) 30%

Emblem and Logo:

- a. The emblem of project, logo and name of the municipality should be affixed by multi colour sticker on the bins and Supplier should also paint messages along purpose to each as specified.
- b. Green colour Bins: "Compostable Waste" in Bengali, Hindi and English language. Blue Colour Bins: "Non-compostable Waste" in Bengali, Hindi and English Language should also be affixed by Screen Print.
- c. The supplier will finalize the content of the message in discussion with KHARDAHA MUNICIPALITY and will provide two sample bins (one in green colour and one in blue colour) with the message and emblem of MISSION NIRMAL BANGLA (U) within 4 days from the issues work / supply order.
- d. The supplier shall provide sample of bins as per specification free of cost to KHARDAHA MUNICIPALITY for approval before production.

6. Submission of Quotations:

6.1 General process of submission

Tenders are to be submitted online through the website, in two folders, at a time for each work, one is for Technical Proposal and the other is Financial Proposal, before the prescribed date and time mentioned in Table-1. Using the Digital Signature Certificate (DSC), the documents are to be uploaded virus scanned and digitally signed. The documents will get encrypted (transformed into non-readable formats).

- i) Application in letter headed pad duly signed in. Letter head should contain full address, telephone no. mobile no. & FAX, e-mail.
- ii) Scanned copy of Online Banking/NEFT, RTGS details towards Earnest Money Deposit (EMD) as prescribed in the NIT against each serial of work if applicable, against in favour of the Chairman, Khardah Municipality.
- iii) Notice Inviting e-Quotation.
- iv) BOQ/Price Schedule

- ii. If any contractor is exempted from payment of EMD, copy of relevant Government Order needs to be furnished.

9. Financial Proposal

i) Financial proposal should contain the following documents in one folder i.e. Bill of quantities - (BOQ) the Quotationer is to quote the rate (for individual item separately) online.

- iii) Quoted rate should be inclusive of all taxes and all other charges.

10. Penalty for suppression / distortion of facts:

If any Tenderer fails to produce the original hard copies of the documents uploaded or any other documents on demand of the Tender Inviting Authority within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the Quotationer will be suspended from participating in the tenders on e-Tender platform for a period of 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the Chairman, Khardah Municipality may take appropriate legal action against such defaulting Quotationer. The authority may ask to show hard copies of all certificates, company details, partnership deeds etc. etc. as uploaded by the Quotationer and allied papers in connection with this tender as and when necessary for verification purpose as per convenience of the authority during processing of this tender.

11. Rejection of Tender

The Tender Inviting authority receives the right to accept or reject any Tender and to cancel the Tender process and reject all Tenders at any time prior to the award of contract without thereby incurring any liability to the affected Tenderer or any obligation to inform the affected Tenders of the ground for Tender Inviting authority's action.
